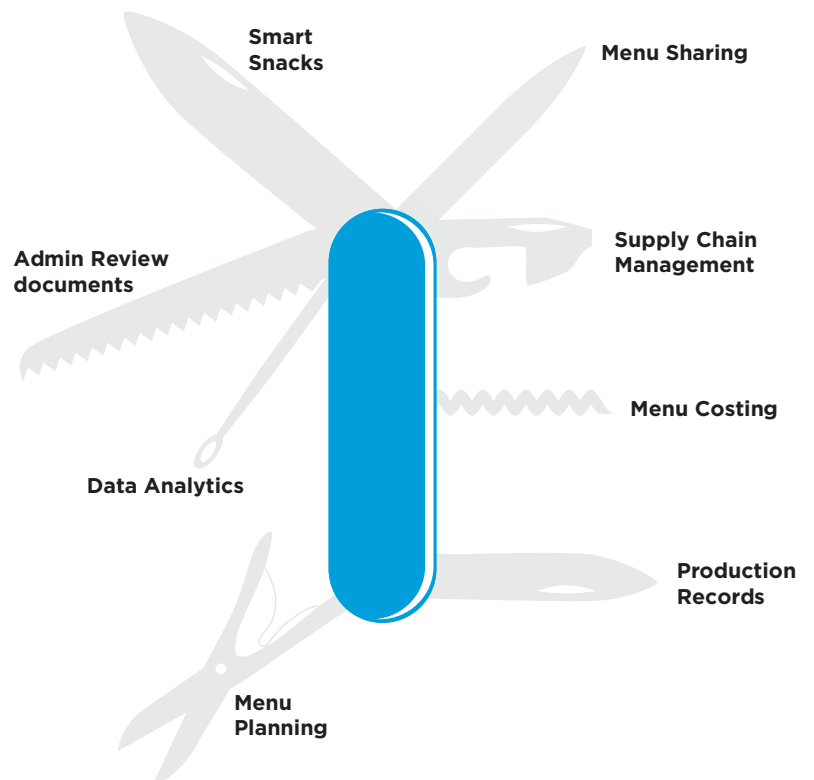

CASE STUDY

KDE Improves Processes with inTEAM

Kentucky's Department of Education (KDE) offers districts statewide a standardized approach to using HHFKA implementation funds utilizing inTEAM's suite of software tools. The results have been remarkable and have assisted KDE with accomplishing a number of key initiatives. State Agency staff completed training provided by inTEAM to train SFA's in implementing the software tools. Instructor-led training, in addition to wide utilization of inTEAM's learning management system, provided in-depth classroom and self-paced training to all KDE staff. Since initial implementation in 2012, over 4,000 menus have been created. Beginning in January 2014, the tools have been utilized to enter menu costs for more than 700 existing menus, 250 production records have been created, and administrative review supplements have been created in 41 out of 74 districts.

The implementation of inTEAM tools has resulted in improvements in KDE's processes, and increased efficiencies in staff utilization, while ensuring compliance with regulations. In addition, the continued use of eLearning allows KDE to monitor and document corrective action to ensure retention and application of skills learned.
